- **DETERMINATIONS**: 16/03691/FUL: Mr A Clayton, Harlow Hill Farmhouse redevelop dilapidated farmhouse; 16/04276/FUL: Mr & Mrs J Freeman-Griffiths, 2 Grange Road two storey extension, single storey rear extension, porch extension PC had no objections to this plan; 16/04355/VARYCO: Mr B Boase, land at Harlow Hill, variation in order to allow different layout in Unit 1
- **GRANTED**:16/03589/CDD, Stamfordham Primary School, single storey extension; 16/03146/FUL: Stamfordham Cricket Club, construction of new re-sited pavilion and storage container
- NOTICE OF PRE APPLICATION: 16/00486/PREAPP Dalton Farm, replace old barn with new barn 'like for like; construction of new lunge pen; replace old horse walker with new; placement of 4 small mobile field shelters in adjacent paddocks. At the present time PC have no objection, provided barn is the same height as existing.

#### **Proposed 1800 homes for Ponteland**

Not accepted as part of Central Government tranch of garden villages, however application is open for comment at the present time. Grave objections would involve traffic with large farm vehicles of particular concern, with the size of the development and narrow roads surrounding it, infrastructure would not be able to cope. Ponteland relief road, GP surgery, school and shops encompassed into the plans. V Jones to email Planning Application details and Clerk to circulate.
