### 18. Minutes of Meeting held on 27 May 2015

## 19. Planning Matters

The Parish Council was consulted on the following application –

**15/01917/LBC**: Listed Building Consent for provision of a retail unit and increase of pitched roof to an existing store room at the rear of the Public House, Swinburne Arms, 31 North Side, Stamfordham. The Parish Council had no objection to the application.

## 21. County Councillor's Report

Cllr Jones reported on the following issues –

- The report on subsidised bus services had now been prepared and finalised. The assumption was that the No 74 service was OK
- New Area Committees were to be held later in the week and local services were on the agenda. There was a proposal to reduce cutting of grass verges. Members were opposed to the reduction of maintenance of grass verges as it would result in difficulties especially at junctions and bends.
- The road from Churston was to be surfaced dressed but it was

not known when.

- Traffic Speed indicators were available to purchase at approximately £3500 each.
- NCC were aware of the problem with the mileage direction signs but there was no indication when they would be corrected.
- There was currently a review of polling stations following the recent elections. Members asked that the Dalton Village Hall polling station be re-instated

A recent fundraising event made over £95 and efforts were being made to set up a "Group" entity and Bank Account. Quotes for work to the play area were being invited.
